

**TERMS AND CONDITIONS IN RESPECT OF
KAI TAK SPORTS PARK – Easter Rewards Promotion
(On 16 to 27 Apr 2025)**

1 Applicable Activity

Redemption Restrictions:

- a) Each participant is required to first become a Friends of KTSP Member to redeem the Reward, provided that he or she is not a current Friends of KTSP Member.
- b) The Reward can only be redeemed once within the Promotion Period by each Member.
- c) The Reward cannot be exchanged for cash or other gifts.

3 Special Terms and Conditions applicable to the Activity

3.1 Terms Used

3.1.1 "Eligible Receipt" means an original machine-printed receipt issued by a merchant at Kai Tak Mall on the date of redemption for an Eligible Transaction. KTSPL does not accept any photocopies or hand-written receipts and reserves the right not to accept any receipts that KTSPL suspects to be invalid, forged or issued not for genuine transactions or on other grounds without any need for explanation.

3.1.2 "Eligible Transaction" means an eligible transaction settled by Electronic Payment methods between anyone and a merchant at Kai Tak Mall, but excludes the following:

- (1) Any single spending below HK\$50;
- (2) Any spending by cash;
- (3) Any payments using Kai Tak Mall physical or electronic gift vouchers/coupons;
- (4) Any payments using physical or electronic cash vouchers/coupons, gift cards/vouchers/coupons, stored value cards or pre-paid cards of merchants at Kai Tak Mall;
- (5) Purchase of any kinds of membership(s);
- (6) Any purchase of pre-paid items, cash vouchers/coupons, gift cards/vouchers/coupons, stored value cards or prepaid cards);
- (7) Any purchase of show/event/concert/exhibition tickets and other ticketing services and any payments of venue or facility booking;
- (8) Any payments of medical and dental/clinic services;
- (9) Adding value to Octopus cards, stored value cards or pre-paid cards;
- (10) Currency exchange;

- (11) Any transactions on KTSP ESHOP, Food Ordering via the KTSP Website, KTSP Mobile App or any online platform of any merchants of Kai Tak Mall;
- (12) Charity donations;
- (13) Tips towards any spending or purchases;
- (14) Any bill payment (including but not limited to payment of telecommunication or utility bills);
- (15) Any bank transactions; insurance transactions and securities & investment transactions;
- (16) Any spending at travel agencies and property agencies;
- (17) Any activity, programme or course provided or hosted by Friends of KTSP or external third parties;
- (18) Any spending of parking or purchase of parking card;
- (19) Any spending in exhibition venues and booths and temporary pop up stores;
- (20) EPS cash withdrawal receipts, credit card withdrawal receipts and receipt copies; or
- (21) Any spending at excluded merchants as stated in KTSP Membership Programme Terms and Conditions (which may be updated from time to time without prior notice).

3.1.3 “KTSP Membership Programme Terms and Conditions” means the Friends of KTSP terms and conditions available on <https://member.kaitaksportspark.com.hk/login/signUp> (which may be updated by KTSPL from time to time).

3.1.4 Other terms not defined in these Terms and Conditions shall have the same meanings as defined in the KTSP Membership Programme Terms and Conditions.

3.2 Registration of Eligible Transactions

3.2.1 For the purpose of calculating the Eligible Transactions spending, all Eligible Transactions spending is required to be registered in accordance with the KTSP Membership Programme Terms and Conditions.

3.2.2 A Member shall forthwith inform KTSPL of any transaction where Benefits (as defined in the KTSP Membership Programme Terms and Conditions) have been obtained/redeemed but such transaction is subsequently cancelled, refunded or reversed for whatever reasons. In such circumstances, if the Member fails to inform KTSPL but it has come to the knowledge of KTSPL of those cancelled, refunded or reversed transaction(s), then either: (a) the Member shall pay to KTSPL forthwith upon notice from KTSPL for the value of the Benefits, which value shall be determined by KTSPL in its sole and absolute

3.4 Copying Eligible Receipts

KTSPL is entitled to make copies of the receipts, invoices or payment slips produced by the Member to KTSPL for audit purpose.

3.5 Marking on Eligible Receipts

KTSPL has the right to make any marks on each Eligible Receipt presented to KTSPL in the course of redemption. Eligible Receipts marked by KTSPL cannot be used again for redeeming gifts / rewards from other promotions unless specified herein.

3.6 Limited Stock

The Rewards are offered on a first-come-first-served basis while stocks last.

3.7 Verification of Identity

Friends of KTSP Members are required to present his or her Friends of KTSP e-membership card for verification at the time of redemption.

3.8 No Exchange

The Reward cannot be exchanged for cash or other gifts.

3.9 Reward Restrictions

Participants may not give away, transfer or sell their Rewards to other.

3.10 No Liability

KTSPL does not warrant that the products and/or services offered by the Designated Merchant or redeemed by the participants in the Activity are of any merchantable quality or fit for any purpose, and disclaims all liability in relation to such products and services. Any participant in the Activity shall waive all his/her rights

and interests, if any, of any natures to pursue against KTSPL. All enquiries and/or complaints in respect of the products and/or services offered by Designated Merchant shall be directed to the relevant Designated Merchant.

3.11 Termination of the Activity

KTSPL has the right to suspend, terminate or cancel the Activity at any time without any prior notice.

4 General Terms and Conditions applicable to the Activity

4.1 Amendment

KTSPL has the right to amend any of these Terms and Conditions at any time without any prior notice.

4.2 Interpretation

KTSPL has the right to interpret these Terms and Conditions. In case of disputes, the decision of KTSPL will be final and binding on all parties concerned.

4.3 English Version Prevails

The Chinese version of these Terms and Conditions are for reference only. In case of discrepancies between the provisions of the English version and the Chinese version, the English version shall prevail.

4.4 Governing Laws

These Terms and Conditions shall be governed by the laws of Hong Kong Special Administrative Region.

3 活動適用的特殊條款與細則

3.1 用語定義

- (11) 任何在啟德體育園電子商店、透過啟德體育園官方網站、啟德體育園流動應用程式進行的食品訂購或任何啟德零售館商戶的線上平台交易；
- (12) 慈善捐款；
- (13) 任何消費或購物的小費；
- (14) 任何帳單支付（包括但不限於電訊或公用事業帳單支付）；
- (15) 任何銀行交易；保險交易與證券及投資交易；
- (16) 任何在旅行社和物業代理的消費；
- (17) 由 KTSPL 或外部第三方提供或主辦的任何活動或課程；
- (18) 任何停車費用或停車卡的購買；
- (19) 在展覽場地、展位和臨時快閃店的任何消費；
- (20) EPS 現金提款收據、信用卡提款收據及收據副本；或
- (21) 任何在 啟德體育園之友會員獎賞計劃之條款及細則中所述的特定商戶的消費（該條款可能會不時更新，恕不另行通知）。

3.1.3 「啟德體育園之友會員獎賞計劃之條款及細則」指 <https://member.kaitaksportspark.com.hk/login/signUp> 所載的條款與條件（KTSPL 可能會不時更新）。

3.1.4 此等條款及細則中未定義的其他術語應具有與啟德體育園之友會員獎賞計劃條款及細則中定義的相同含義。

3.2 合資格交易登記

3.2.1 所有合資格交易須根據啟德體育園之友會員獎賞計劃條款及細則作出登記，方會計算在合資格交易的消費金額內。
