

TERMS AND CONDITIONS IN RESPECT OF
KAI TAK MALL – Hang Seng Credit Card Shopping Rewards 2025
(From 1 September 2025 to 31 October 2025)

1 Applicable Activity

By participating in the activity organized by Kai Tak Sports Park Limited (“**KTSP**”) as set out in Clause 2 below (the “**Activity**”), a participant is deemed to have read, understood and agreed to the terms and conditions applicable to the Activity (“**Terms and Conditions**”).

2 Details of the Activity

Activity: Kai Tak Mall – Hang Seng Credit Card **Shopping** Rewards 2025

Promotion Period: 1 September 2025 to 31 October 2025 (both days inclusive)

Venue: Kai Tak Mall, Kai Tak Arena, Health and Wellness Centre, Dining Cove

Place of Redemption: Concierge, Level G, Kai Tak Mall 2

Redemption Hours: 10AM – 10PM

2.1 Promotional Offer 1:

During the Promotion Period, participants who are Friends of KTSP Members (“**Members**”), subject to these Terms and Conditions, may redeem the following rewards (“**Rewards**”) on the date of Eligible Transaction upon same-day cumulative spending of the designated amount at the merchants within the Venue with the same Eligible Credit Card.

Same-day cumulative spending is calculated based on a minimum of 2 and a maximum of 4 Eligible Receipts issued by the different merchants within the Venue during the Promotion Period. Each Eligible Receipt must contain a minimum spending of HK\$50 (excluding spending by Kai Tak Mall physical/ electronic gift voucher(s) and/or any physical/electronic gift voucher(s) issued by merchants). Spending on different transaction days cannot be merged. If 2 or more Eligible Receipts are used, they must be issued by at least 2 different

merchants. The eligible spending amount applies to the net amount after deduction of all applicable discounts, cash vouchers, and/or gift cards etc.

Members must register the Eligible Receipts and the corresponding original electronic payment slips of the Eligible Credit Card or the screenshots of transaction records of the mobile payment of their Eligible Transactions at the designated place of redemption in person on the date of the Eligible Transaction(s).

Redemption Restrictions:

- a) Each participant is required to first become a Friends of KTSP Member to redeem Rewards, provided that he or she is not a current Friends of KTSP Member.
- b) Rewards can only be redeemed on the day of Eligible Transaction and the reward from each spending tier of same-day cumulative spending can only be redeemed once per day by each Member during the Promotion Period.
- c) Members are required to use the same Eligible Credit Card when making Eligible Transactions to redeem the Promotional Offer 1 in order to reach the designated same-day cumulative spending on the date of Eligible Transactions.
- d) Each Eligible Receipt can only be used for redemption for the Rewards once (**regardless of the tiers**), and any Eligible Receipt marked by KTSPL cannot be used again for redeeming gift/reward from the same Activity.
- e) The Rewards cannot be exchanged for cash or other gifts.
- f) The Rewards will be given to the Member in the form of electronic coupons in the 'KAI TAK SPORTS PARK' Mobile App. The usage of the coupons is subject to the terms and conditions applicable to the coupon and the relevant terms and conditions of the designated merchant who accepts such coupon ("**Designated Merchants**").
- g) Cash Coupons can be used as cash at any of the Designated Merchants at the Venue. Shopping Coupon can only be used upon designated spending at any of the Designated Merchants at the Venue and only one per transaction.
- h) Members shall settle the balance of transactions with Eligible Card upon using the Cash Coupons and Shopping Coupons.

2.2 Promotional Offer 2:

During the Promotion Period, **subject to these Terms and Conditions**, Eligible Credit Card cardholders can enjoy various shopping and dining privileges at offering merchants at the Venue ("**Offering Merchants**") by spending with an Eligible Credit Card. Please refer to the details [here](#), subject to the relevant terms and conditions of such Offering Merchants.

Redemption Restrictions:

- a) Promotional Offer 2 can only be enjoyed at Offering Merchants at the Venue with an Eligible Credit Card.

- b) Promotional Offer 2 can be used in conjunction with Promotional Offer 1, but cannot be transferred or exchanged for cash, other products, services or discounts or used in conjunction with other promotional programmes, offers, discounts, vouchers or VIP privileges (unless otherwise specified). Eligible Credit Card cardholders may check with the Offering Merchants for details.

3 Special Terms and Conditions applicable to the Activity

3.1 Terms Used

3.1.1 “Eligible Credit Card” refers to Hang Seng Credit Card, Affinity Card enjoy Commercial Card, enjoy Business Card and enjoy Spending Card, but excluding other Commercial Card, other Business Card, other Spending Card, Hang Seng Bupa Card, Renminbi Credit Card, USD Visa Gold Card, e-shopping Mastercard and Private Label Cards. Subject to these Terms and Conditions, a Member may use an Eligible Credit Card via a mobile payment tool (including Apple Pay, Google Pay and Samsung Pay but excluding any e-wallet) to settle an Eligible Transaction.

3.1.2 “Eligible Receipt” means an original machine-printed receipt issued by a merchant within the Venue on the date of redemption for an Eligible Transaction. KTSPL does not accept any photocopies or hand-written receipts and reserves the right not to accept any receipts that KTSPL suspects to be invalid, forged or issued not for genuine transactions or on other grounds without any need for explanation.

3.1.3 “Eligible Transaction” means an eligible transaction settled by the Eligible Credit Card between anyone and a merchant within the Venue, but excludes the following:

- (1) Any single spending below HK\$50;
- (2) Any spending by cash;
- (3) Any spending by e-wallets including AlipayHK, WeChat Pay HK, Tap & Go and PayMe by HSBC
- (4) Any spending amount settled by +FUN Dollars/ Merchant Dollars or yuu Points
- (5) Any payments using Kai Tak Mall physical or electronic gift vouchers/coupons;
- (6) Any payments using physical or electronic cash vouchers/coupons, gift cards/vouchers/coupons, stored value cards or pre-paid cards of merchants within the Venue;
- (7) Purchase of any kinds of membership(s);
- (8) Any purchase of pre-paid items, cash vouchers/coupons, gift cards/vouchers/coupons, stored value cards or prepaid cards);
- (9) Any purchase of show/event/concert/exhibition tickets and other ticketing services and any payments of venue or facility booking;
- (10) Any payments of medical and dental/clinic services;
- (11) Adding value to Octopus cards, stored value cards or pre-paid cards;

- (12) Currency exchange;
- (13) Any transactions on KTSP ESHOP, Food Ordering via the KTSP Website, KTSP Mobile App or any online platform of any merchants within the Venue;
- (14) Charity donations;
- (15) Tips towards any spending or purchases;
- (16) Any bill payment (including but not limited to payment of telecommunication or utility bills);
- (17) Any bank transactions; insurance transactions and securities & investment transactions;
- (18) Any spending at travel agencies and property agencies;
- (19) Any activity, programme or course provided or hosted by Friends of KTSP or external third parties;
- (20) Any spending of parking or purchase of parking card;
- (21) Any spending in exhibition venues and booths and temporary pop up stores;
- (22) EPS cash withdrawal receipts, credit card withdrawal receipts and receipt copies; or
- (23) Any spending at excluded merchants as stated in KTSP Membership Programme Terms and Conditions (which may be updated from time to time without prior notice);

3.1.4 “KTSP Membership Programme Terms and Conditions” means the Friends of KTSP terms and conditions available on <https://member.kaitakSPORTSPARK.com.hk/login/signUp> (which may be updated by KTSP from time to time).

3.1.5 Other terms not defined in these Terms and Conditions shall have the same meanings as defined in the KTSP Membership Programme Terms and Conditions.

3.2 Registration of Eligible Transactions

3.2.1 For the purpose of calculating the Eligible Transactions spending, all Eligible Transactions spending is required to be registered in accordance with the KTSP Membership Programme Terms and Conditions.

3.2.2 A Member shall forthwith inform KTSP of any transaction where Benefits (as defined in the KTSP Membership Programme Terms and Conditions) have been obtained/redeemed but such transaction is subsequently cancelled, refunded or reversed for whatever reasons. In such circumstances, if the Member fails to inform KTSP but it has come to the knowledge of KTSP of those cancelled, refunded or reversed transaction(s), then either: (a) the Member shall pay to KTSP forthwith upon notice from KTSP for the value of the Benefits, which value shall be determined by KTSP in its sole and absolute discretion; or (b) KTSP shall be entitled to deduct the Rewards earned from the said transaction(s) from his/her account. The Member agrees that the aforesaid payment by the Member to KTSP is an agreed liquidated damages but not a penalty.

3.3 Keeping of Information

KT SPL has the right to record the full name of each Eligible Credit Card cardholder, the first 6 digits and the last 4 digits of their Eligible Credit Card and the information stated on each Eligible Receipt in the course of redemption for audit purpose. Member must keep all original sales slips/credit card slips of the Eligible Transactions. In case of dispute, Hang Seng and KT SPL may at any time ask customers to submit these slips, and/or further documents or evidence for inspection, and Hang Seng and KT SPL may keep them. By collecting the Rewards, Member agrees that KT SPL may collect, hold, process and use their personal data in accordance with the Privacy Policy Statement of KT SPL. 3.4 Copying Eligible Receipts

KT SPL is entitled to make copies of the receipts, invoices or payment slips produced by the Member to KT SPL for audit purpose.

3.5 Marking on Eligible Receipts

KT SPL has the right to make any marks on each Eligible Receipt presented to KT SPL in the course of redemption. Eligible Receipts marked by KT SPL cannot be used again for redeeming gifts / rewards from other promotions unless specified herein.

3.6 Limited Stock

The Rewards are offered on a first-come-first-served basis while stocks last.

3.7 Verification of Identity

Friends of KTSP Members are required to present his or her Friends of KTSP e-membership card for verification at the time of redemption.

3.8 No Exchange

The Rewards cannot be exchanged for cash or other gifts.

3.9 Reward Restrictions

Participants may not give away, transfer or sell their Rewards to other.

3.10 No Liability

Hang Seng Bank Limited ("Hang Seng") and KT SPL do not warrant that the products and/or services offered by the Designated Merchant or redeemed by the participants in the Activity are of any merchantable quality or fit for any purpose, and disclaims all liability in relation to such products and services. Any participant in the Activity shall waive all his/her rights and interests, if any, of any natures to pursue against Hang Seng and

KT SPL. All enquiries and/or complaints in respect of the products and/or services offered by Designated Merchant shall be directed to the relevant Designated Merchant.

3.11 Termination of the Activity

Hang Seng and KT SPL have the right to suspend, terminate or cancel the Activity at any time without any prior notice.

4 General Terms and Conditions applicable to the Activity

4.1 Amendment

Hang Seng and KT SPL have the right to amend any of these Terms and Conditions at any time without any prior notice.

4.2 Interpretation

Hang Seng and KT SPL have the right to interpret these Terms and Conditions. In case of disputes, the decision of KT SPL will be final and binding on all parties concerned.

4.3 English Version Prevails

The Chinese version of these Terms and Conditions are for reference only. In case of discrepancies between the provisions of the English version and the Chinese version, the English version shall prevail.

4.4 Governing Laws

These Terms and Conditions shall be governed by the laws of Hong Kong Special Administrative Region.

1 適用活動

2 活動詳情

換領地點：啟德零售館 2 地下禮賓部

換領時間：上午 10 點至晚上 10 點

2.1 推廣優惠 1：

於推廣期內，登記為啟德體育園之友會員的參與者(「會員」)，於活動地點內的商戶以同一張合資格信用卡作同日累積簽賬並達到指定金額，即可在合資格交易當日兌換以下獎賞(「獎賞」)。獎賞受以下條款及細則約束。

同日累積簽賬金額是根據於活動地點內的商戶作即日消費，並由不同商戶發出之不少於 2 張及不多於 4 張的合資格收據計算。每張合資格收據金額最少為港幣 50 元(啟德零售館實體/電子禮券及/或由商戶發出之任何實體/電子禮券作消費之金額除外)。不同日子的消費，不得合併計算。如合資格收據為兩張或以上，即須至少由 2 間不同商戶發出。合資格消費金額為扣除所有適用的折扣、現金券、及/或禮品卡交易後的消費淨額。

- (6) 任何使用實體或電子現金券/優惠券、禮品卡/禮券/優惠券、儲值卡或活動地點內的商戶的預付卡進行的付款；
- (7) 購買任何種類的會籍；
- (8) 購買預付產品、現金券/優惠券、禮品卡/禮券/優惠券、儲值卡或預付卡；
- (9) 購買任何演出/活動/音樂會/展覽門票及其他票務服務的交易，以及任何場地或設施預訂的付款；
- (10) 任何醫療和牙科/診所服務的付款；
- (11) 為八達通卡、儲值卡或預付卡增值；
- (12) 貨幣兌換；
- (13) 任何在啟德體育園電子商店、透過啟德體育園官方網站、啟德體育園流動應用程式進行的食品訂購或任何活動地點內的商戶的線上平台交易；
- (14) 慈善捐款；
- (15) 任何消費或購物的小費；
- (16) 任何帳單支付（包括但不限於電訊或公用事業帳單支付）；
- (17) 任何銀行交易；保險交易與證券及投資交易；
- (18) 任何在旅行社和物業代理的消費；
- (19) 由 啟德體育園或外部第三方提供或主辦的任何活動或課程；
- (20) 任何停車費用或停車卡的購買；

- (21) 在展覽場地、展位和臨時快閃店的任何消費；
- (22) EPS 現金提款收據、信用卡提款收據及收據副本；或
- (23) 任何在 啟德體育園之友會員獎賞計劃之條款及細則中所述的特定商戶的消費（該條款可能會不時更新，恕不另行通知）。

3.1.4 「啟德體育園之友會員獎賞計劃之條款及細則」指 <https://member.kaitakSPORTSPARK.com.hk/login/signUp> 所載的條款與條件（啟德體育園可能會不時更新）。

3.1.5 此等條款及細則中未定義的其他術語應具有與啟德體育園之友會員獎賞計劃條款及細則中定義的相同含義。

3.2 合資格交易登記

3.2.1 所有合資格交易須根據啟德體育園之友會員獎賞計劃條款及細則作出登記，方會計算在合資格交易的消費金額內。
