

**TERMS AND CONDITIONS IN RESPECT OF
KAI TAK MALL – BOC Credit Card Rewards 2025
(From 1 July 2025 to 31 August 2025)**

1 Applicable Activity

By participating in the activity organized by Kai Tak Sports Park Limited (“**KTSP**”) as set out in Clause 2 below (the “**Activity**”), a participant is deemed to have read, understood and agreed to the terms and conditions applicable to the Activity (“**Terms and Conditions**”).

2 Details of the Activity

Activity: Kai Tak Mall– BOC Credit Card Rewards 2025

Promotion Period: 1 July 2025 to 31 August 2025 (both days inclusive)

Venue: Kai Tak Mall, Kai Tak Arena, Health and Wellness Centre

Place of Redemption: Concierge, Level G, Kai Tak Mall 2

Redemption Hours: 10AM – 10PM

2.1 Promotion Offer 1:

During the Promotion Period, participants who are Friends of KTSP Members (“**Members**”), subject to these Terms and Conditions, may redeem the following rewards (“**Rewards**”) on the date of Eligible Transaction upon same-day spending of the designated amount at the merchants within the Venue with the same Eligible BOC Credit Card or such card bounded with the Eligible Mobile Payment.

Same-Day Cumulative Spending is calculated based on a minimum of 2 and a maximum of 4 Eligible Receipts issued by at least 2 different merchants within the Venue during the Promotion Period. Each Eligible Receipt must contain a minimum spending of HK\$50 (excluding spending by Kai Tak Mall and/ or merchant’s physical cash coupon / physical voucher / electronic cash coupon / electronic voucher). Spending on different transaction days cannot be merged. If 2 or more Eligible Receipts are used, they must be issued by at least 2 different merchants. Spending on different transaction days cannot be

merged. The eligible spending amount applies to the final net amount after deduction of all applicable discounts, cash coupons, and/or gift cards etc.

Members must register their Eligible Transactions with their physical Eligible BOC Credit Card / the Eligible BOC Credit Card bound with the Eligible Mobile Payment (if applicable), Eligible Receipts and the corresponding original electronic payment slips of the Eligible Credit Card or the screenshots of transaction records of the Eligible mobile payment of their Eligible Transactions at the Place of Redemption to redeem the Rewards on the date of the Eligible Transaction(s).

Redemption Restrictions:

- a) Each Eligible BOC Credit Card Cardholder is required to first become a Friends of KTSP Member to redeem Rewards, provided that he or she is not a current Friends of KTSP Member. Member's name registered for the Friends of KTSP Member Program membership must be the same as the one displayed on the Eligible BOC Credit Card.
- b) Rewards can only be redeemed on the day of Eligible Transaction and the reward from each spending tier of Same-Day Cumulative Spending can only be redeemed once per day by each Member during the Promotion Period.
- c) Members are required to use the same Eligible BOC Credit Card when making Eligible Transactions stated in 2.1 to redeem the Promotional Offer 1 in order to reach the designated Same-Day Cumulative Spending on the date of Eligible Transactions.
- d) The Rewards are subject to a quota and are offered on a first-come-first-served basis.
- e) Each Eligible Receipt can only be used for redemption for each tier of Rewards once and Eligible Receipts marked by KTSPL cannot be used again for redeeming gifts/rewards from the same Activity.
- f) The Reward cannot be exchanged for cash or other gifts.
- g) The Reward will be given to the Member in the form of electronic coupons in the 'KAI TAK SPORTS PARK' Mobile App. The Reward must be used before 30 November 2025. The usage of the coupons is subject to the terms and conditions applicable to the coupon and the relevant terms and conditions of the designated merchant who accepts such coupon ("**Designated Merchant**").

- h) e-Cash Coupon can be used as cash at any of the Designated Merchants at the Venue. e-Shopping Coupon can only be used upon designated spending at the Designated Merchants at the Venue, and maximum one e-Shopping Coupon in a single transaction.

2.2 Promotional Offer 2:

During the Promotion Period, members **can** enjoy various shopping privileges at selected merchants at the Venue by spending with Eligible BOC Credit Card (including Eligible Mobile Payment) and/or Physical BOC Credit Card bearing the BOC logo issued in the mainland. Please refer to the selected merchants offer details [here](#), subject to the relevant terms and conditions of such Selected Merchants.

Redemption Restrictions:

- a) Promotional Offer 2 cannot be transferred or exchanged for cash, other products, services or discounts or used in conjunction with other promotional programmes, offers, discounts, vouchers or VIP privileges (unless otherwise specified). Eligible Credit Card holders may check with the Offering Merchants for details.

3 Special Terms and Conditions applicable to the Activity

3.1 Terms Used

3.1.1 “Eligible BOC Credit Card” refers to any physical cards of BOC Credit Cards, BOC Dual Currency Cards and BOC Co-branded Cards issued in Hong Kong by BOC Credit Card (International) Limited (the “Company”) bearing the BOC logo, or transaction made by Apple Pay, Google Pay or Samsung Pay or Huawei Pay of that these physical cards (if applicable) (“Eligible Mobile Payment”) bearing the BOC logo but excluding BOC Credit Cards issued in the mainland and Macau, USD Credit Cards, Private Label Cards, BOC Purchasing Cards and Intown Cards. All transactions made via AlipayHK, Alipay, WeChat PayHK, WeChat Pay, UnionPay App, BoC Pay+ and other designated payment means / e-Wallet as decided by the Company, and split transactions will not be accepted.

3.1.2 “Eligible Receipt” means (1) an original machine-printed credit card payment slips issued by a merchant or the screenshots of transaction records of the Eligible Mobile Payment within the Venue on the date of redemption for an Eligible Transaction, showing that the Eligible Transaction was settled by an Eligible BOC Credit Card / Eligible Mobile Payment (each with a minimum spending of HK\$50); and (2) the corresponding original machine-printed merchant receipts. All Eligible Receipt have to be issued from at least 2 different merchants. KTSPL does not accept any photocopies or hand-written receipts and

reserves the right not to accept any receipts that KTSPL suspects to be invalid, forged or issued not for genuine transactions or on other grounds without any need for explanation.

3.1.3 “Eligible Transaction” means an eligible transaction settled by the Eligible Credit Card between anyone and a merchant within the Venue, but excludes the following:

- (1) Any single spending below HK\$50;
- (2) Any spending by cash;
- (3) Any payments using Kai Tak Mall physical or electronic gift vouchers/coupons;
- (4) Any payments using physical or electronic cash vouchers/coupons, gift cards/vouchers/coupons, stored value cards or pre-paid cards of merchants within the Venue;
- (5) Purchase of any kinds of membership(s);
- (6) Any purchase of pre-paid items, cash coupons/vouchers, gift cards/vouchers/coupons, stored value cards or prepaid cards);
- (7) Any purchase of show/event/concert/exhibition tickets and other ticketing services and any payments of venue or facility booking;
- (8) Any payments of medical and dental/clinic services;
- (9) Adding value to Octopus cards, stored value cards or pre-paid cards;
- (10) Currency exchange;
- (11) Any transactions on KTSP ESHOP, Food Ordering via the KTSP Website, KTSP Mobile App or any online platform of any merchants within the Venue;
- (12) Charity donations;
- (13) Tips towards any spending or purchases;
- (14) Any bill payment (including but not limited to payment of telecommunication or utility bills);
- (15) Any bank transactions; insurance transactions and securities & investment transactions;
- (16) Any spending at travel agencies and property agencies;
- (17) Any activity, programme or course provided or hosted by Friends of KTSP or external third parties;
- (18) Any spending of parking or purchase of parking card;
- (19) Any spending in exhibition venues and booths and temporary pop up stores;

- (20) EPS cash withdrawal receipts, credit card withdrawal receipts and receipt copies; or
- (21) Any spending at excluded merchants as stated in KTSP Membership Programme Terms and Conditions (which may be updated from time to time without prior notice);

3.1.4 “KTSP Membership Programme Terms and Conditions” means the Friends of KTSP terms and conditions available on <https://member.kaitakSPORTSPARK.com.hk/login/signUp> (which may be updated by KTSPL from time to time).

3.1.5 Other terms not defined in these Terms and Conditions shall have the same meanings as defined in the KTSP Membership Programme Terms and Conditions.

3.2 Registration of Eligible Transactions

3.2.1 For the purpose of calculating the Eligible Transactions spending, all Eligible Transactions spending is required to be registered in accordance with the KTSP Membership Programme Terms and Conditions.

3.2.2 A Member shall forthwith inform KTSPL of any transaction where Benefits (as defined in the KTSP Membership Programme Terms and Conditions) have been obtained/redeemed but such transaction is subsequently cancelled, refunded or reversed for whatever reasons. In such circumstances, if the Member fails to inform KTSPL but it has come to the knowledge of KTSPL of those cancelled, refunded or reversed transaction(s), then either: (a) the Member shall pay to KTSPL forthwith upon notice from KTSPL for the value of the Benefits, which value shall be determined by KTSPL in its sole and absolute discretion; or (b) KTSPL shall be entitled to deduct the Rewards earned from the said transaction(s) from his/her account. The Member agrees that the aforesaid payment by the Member to KTSPL is an agreed liquidated damages but not a penalty.

3.3 Keeping of Information

KTSPL has the right to record the full name of each Eligible BOC Credit Card holder, payment account holder of Eligible Mobile Payment, the first 6 digits and the last 4 digits of their Eligible BOC Credit Card number (if applicable) and the spending amount of each Eligible Receipt in the course of redemption for audit purpose. By collecting the Reward, Member agrees that KTSPL may collect, hold, process and use their personal data in accordance with the Privacy Policy Statement of KTSPL. For further information about the Privacy Policy Statement and the privacy policy of KTSPL, please refer to the website at <https://www.kaitakSPORTSPARK.com.hk/privacyPolicy>.

3.4 Copying Eligible Receipts

KTSP is entitled to make copies of the receipts, invoices or payment slips produced by the Member to KTSP for audit purpose.

3.5 Marking on Eligible Receipts

KTSP has the right to make any marks on each Eligible Receipt presented to KTSP in the course of redemption. Eligible Receipts marked by KTSP cannot be used again for redeeming gifts / rewards from other promotions unless specified herein.

3.6 Limited Stock

The Rewards are offered on a first-come-first-served basis while stocks last.

3.7 Verification of Identity

Friends of KTSP Members are required to present his or her Friends of KTSP e-membership card for verification at the time of redemption.

3.8 No Exchange

The Reward cannot be exchanged for cash or other gifts.

3.9 Reward Restrictions

Participants may not give away, transfer or sell their Rewards to other.

3.10 No Liability

KTSP does not warrant that the products and/or services offered by the Designated Merchant or redeemed by the participants in the Activity are of any merchantable quality or fit for any purpose, and disclaims all liability in relation to such products and services. Any participant in the Activity shall waive all his/her rights and interests, if any, of any natures to pursue against KTSP. All enquiries and/or complaints in respect of the products and/or services offered by Designated Merchant shall be directed to the relevant Designated Merchant.

3.11 Termination of the Activity

KTSP has the right to suspend, terminate or cancel the Activity at any time without any prior notice.

4 General Terms and Conditions applicable to the Activity

4.1 Amendment

KTSP has the right to amend any of these Terms and Conditions at any time without any prior notice.

4.2 Interpretation

KT SPL has the right to interpret these Terms and Conditions. In case of disputes, the decision of KT SPL will be final and binding on all parties concerned.

4.3 English Version Prevails

The Chinese version of these Terms and Conditions are for reference only. In case of discrepancies between the provisions of the English version and the Chinese version, the English version shall prevail.

4.4 Governing Laws

These Terms and Conditions shall be governed by the laws of Hong Kong Special Administrative Region.

1 適用活動

2 活動詳情

2.1 推廣優惠 1：

推廣期內，同日累積簽賬是根據於活動地點內的不同商戶作同日消費，並由不同商戶發出之不少於 2 張及不多於 4 張的合資格收據計算。每張合資格收據金額最少為港幣 50 元，以啟德零售館及/或由商戶發出之實體現金券/實體或禮券/電子現金券/電子禮券除外。如合資格收據為兩張或以上，即須至少由 2 間不同商戶發出。不同日子的簽賬，不得合併計算。合資格消費金額為扣除所有適用的折扣、現金券及/或禮品卡交易後的消費淨額。

3 活動適用的特殊條款與細則

3.1 用語定義

3.1.1 「合資格中銀信用卡」是指由中銀信用卡(國際)有限公司(「卡公司」)於香港發行並印有標誌之中

銀信用卡、中銀雙幣卡及中銀聯營卡之實體卡，當中包括透過其 Apple Pay、Google Pay 或 Samsung Pay (如適用) (「合資格流動支付」)所進行之簽賬，並不適用於在內地及澳門發行的中銀信用卡、美金卡、私人客戶卡及 Intown 網上卡。恕不接受透過 AlipayHK、WeChat PayHK、支付宝、微信支付、Alipay、WeChat Pay、雲閃付、BoC Pay+ 及其他由卡公司不時指定的支付/電子錢包交易及任何分拆簽賬。

3.1.2 「合資格收據」是指(1) 活動地點內的商戶在兌換日期所簽發之合資格交易的信用卡付款存根正本/合資格

流動支付之交易記錄截圖，顯示該合格交易是由合資格中銀信用卡/合資格流動支付結算(每張合資格收據金額最少為港幣 50 元)，及 (2) 相應機印單據正本。所有合資格收據須至少由 2 間不同合資格商戶發出。KTSPL 不接受任何影印本或手寫收據，並保留權利拒不接受其懷疑為無效、偽造或非針對真實交易簽發的任何收據或基於其他理由拒不接受任何收據，而無需作出任何解釋。

3.1.3 「合資格交易」是指任何會員與活動地點內的商戶之間透過合資格中銀信用卡/合資格流動支付所綁定

- (8) 任何醫療和牙科/診所服務的付款；
- (9) 為八達通卡、儲值卡或預付卡增值；

- (10) 貨幣兌換；
- (11) 任何在啟德體育園電子商店、透過啟德體育園官方網站、啟德體育園流動應用程式進行的食品訂購或任何活動地點內的商戶的線上平台交易；
- (12) 慈善捐款；
- (13) 任何消費或購物的小費；
- (14) 任何帳單支付（包括但不限於電訊或公用事業帳單支付）；
- (15) 任何銀行交易；保險交易與證券及投資交易；
- (16) 任何在旅行社和物業代理的消費；
- (17) 由 KTSPL 或外部第三方提供或主辦的任何活動或課程；
- (18) 任何停車費用或停車卡的購買；
- (19) 在展覽場地、展位和臨時快閃店的任何消費；
- (20) EPS 現金提款收據、信用卡提款收據及收據副本；或
- (21) 任何在 啟德體育園之友會員獎賞計劃之條款及細則中所述的特定商戶的消費（該條款可能會不時更新，恕不另行通知）。

3.1.4 「 啟 德 體 育 園 之 友 會 員 獎 賞 計 劃 之 條 款 及 細 則 」 指
<https://member.kaitakSPORTSPARK.com.hk/login/signUp> 所載的條款與條件（KTSPL 可能會不時更新）。

3.1.5 此等條款及細則中未定義的其他術語應具有與啟德體育園之友會員獎賞計劃條款及細則中定義的相同含義。

3.2 合資格交易登記

3.2.1 所有合資格交易須根據啟德體育園之友會員獎賞計劃條款及細則作出登記，方會計算在合資格交易的消費金額內。

3.4 複製合資格收據

KTSPL 有權在兌換過程中對出示給 KTSPL 的每張合資格收據製作並保留一份電子副本，以供審計之用。
